Dear Devotees,

Shri Ubrangala Mahadeva Parvathi Shri Shasthara temple is an ancient temple of historical importance in the Kasaragod ditrict of Kerala state. This temple stands on an elevated platform amidst the lush green paddy fields and areca gardens of Ubrangala village. Though situated in the rural place, this holy shrine has good approach roads for easy access.

Shri Mahadeva Parvathi, the divine couple, are the presiding deities of this temple. Lord Shri Shasthara is also worshipped in this temple in a unique manner. This temple is popularly known as "Vadakke Sabarimala," as the one must ascend 18 steps to have darshan of deities. Shri Shasthara moolasthanam is situated in a nearby hillock in Katnooji. This is one of the few temples in Kerala where "Paatu utsava" is celebrated for Shri Shasthara. It is again one of the few temples where Shri Parashurama is one of the deities. The other deities are Shri. Mahaganapati, Shri. Subrahmanya and Naga sannidhi. Shri. Dhoomavathi daivasthanam is nearby.

This holy shrine was last renovated 4 decades ago, in 1982, when the last Brahmakalashotsava was performed. Jeernodhara samiti was formed in 2015 and a budget of 2.5 crore rupees was prepared. Anujna kalasha was performed on January 30th, 2017, by late Brahmashree Delampady Balakrishna Tantry. Renovation of sanctum sanctorum and Namaskara mantapa along with the copper covering of roof were undertaken in the first phase. Suttugopura's roof repairs, outer prangana repairs, ashtangana widening, outer compound wall plastering, approach bridge construction across the Ubrangala rivulet have been undertaken. Nadappura platform stabilisation and roof work are in process, as also temple granite laying work. Simultaneously, work is progressing at the Dhoomavati gudi site. Much needed Anna Chatra work has just begun.

Because of Covid situation, the renovation works suffered a major setback and had to be stopped for more than a year. With the generous donation by devotees, coupled with shramadana works by villagers the jeernodhara works have now picked up pace again.

Now, temple's "Naveekarana Punarprathista Ashtabandha Brahmakalashotsavam" have been planned to be held under the direction of Brahmashree Delampady Ganesh Tantry from December 25th, 2022, to 2nd January 2023. A Brahmakalashotsava committee has been formed.

We earnestly appeal to all the devotees to donate liberally for the Jeernodhara works and the upcoming Brahmakalashotsavam, including 'Annadana Seva'.

It is of note that the government of India, ministry of finance in its official gazette on November 28th, 1972, had granted exemption for donations for renovation & repair of the temple, under the category of 80G(2)(b) with the recognition under the category of the temple being a place of historical, archaeological & artistic importance or a place of public worship of renown throughout the state or states.

In exercise of the powers conferred by sub-section (2)(b) of section 80G of the Income-tax Act, 1961 (43 of 1961), the Central Government hereby notifies Ubrangala Shree Mahadeva Parvathi and Kudkuli Shri Durga Parameshwari Temples, Ubrangala Village, Kasaragod Taluk, P. O. Kumbdaje, to be places of public worship of renown throughout the State of Kerala for the purposes of the said section

This ancient temple (along with Kudkuli Shri Durga Parameshwari Temple, Ubrangala village) has been recognised by the Government of India in the official gazette of Ministry of finance, and has been granted income tax exemption under 80G(2)(b) on 28.11.1972 as a one time permanent recognition.

{80G(2)(b): any sums paid by the assesses in the previous year as donations for the renovation or repair of any such temple, mosque, gurdwara, church or other place as is notified by the Central Government in the Official Gazette to be of historic, archacological or artistic importance or to be a place of public worship of renown throughout any State or States}.
